





The PBA 2V2 PBA JUNIOR ADULT / YOUTH League will bowl on NOV 26TH TUESDAY 6:20 PM Practice with a start time of 6:30 at BOWLERO MELBOURNE. The league will have a scheduled starting date of NOV. 26TH and a scheduled ending date of MAY 13TH and will participate for a total of 25 weeks. The league will not bowl on the following dates: DEC 31

Rule 2. Teams will have a playing strength of Doubles (2 members). Anyone under suspension by the responsible league official and USBC is ineligible to participate in the league.

Rule 3 Each league member will pay \$16 at each league session; \$15 will cover the cost of bowling, and \$1 will be the First Place award. All league members must pay their bowling fees on time to remain in the league.

Rule 4. Bowlers will establish their league average in their first league session.

Rule 5. The league will determine wins and losses. Handicap will be 100% of the difference between a bowler's average and a scratch figure of 200.

Rule 6. The league will be certified through USBC. Membership fees must be paid before the completion of the bowler's third session of competition.

Rule 7. The minimum legal lineup of 1 player must be present before the completion of the Third frame of each game. Regular members and substitutes count toward a legal lineup.

Rule 8. When bowling in a known forfeit situation or scheduled against a non-existent team, the team must bowl at least the team average less 10 pins per player to earn the points.

Rule 9. Absentee and vacancy scores will be allowed when a team has a legal lineup, but less than a full lineup at the start of any game in a series. The absentee score will be the absent member's average minus 10 pins.

Rule 10. All league games must be bowled as scheduled except when they are postponed or pre-bowled by authorization of the league supervisor, unless authority is granted by an appointed committee or the league official. (Refer to USBC Rule 117d, Item 2.) The league supervisor / official / committee must grant a postponement when a team is unable to field a legal lineup due to reasons beyond its control. Team and individual unopposed bowling is/ is not allowed and scores are recognized for league awards. (Refer to USBC Rule 117e, Item 7.)

Rule 11. A bowler who arrives late may enter the game provided 3 frames have not been completed. In this situation frames missed may be made up.

Rule 12. Team position standings shall be determined on a point basis, with 2 point(s) awarded for each individual game won and 2 point(s) awarded for the high team series in each match. A total of 18 points could be won.

Rule 13. A league member may not finish any game of a series before his/ her teammates or opponents, except in cases of an emergency or being prearranged based on a good cause. The league supervisor / official will make the determination. Such scores will count in deciding the game and bowler's average, and for qualifying for USBC Youth awards and league awards.
